

LICENSE

By registering this software with John McKernon Software, you indicate your acceptance of the licensing terms shown below. If you cannot accept these terms: Do not register the software, return it and this form immediately to your dealer, and destroy any copies you may have made.

SOFTWARE LICENSING TERMS

This license applies to both *Lightwright* and *Beamwright*.

The software is licensed on an Individual, Student, or Institutional basis.

If you have an Individual or Student registration, this means only one person (one concurrent user) can use it at a time with the serial number shown on the reverse side of this page. For example, you can use one copy at the office and a second copy on the road, just as long as you do not use more than one copy at a time.

If you have an Institutional registration, this means up to six people (six concurrent users) can be using *Lightwright* at any time with the serial number shown on the reverse side of this page.

Your license for *Lightwright* allows you to use either the Windows or Macintosh version of the software and to freely move back and forth between these operating systems so long as you do not at any time exceed the maximum number of concurrent users permitted under the terms of this license.

There is no functional difference between the software in the licenses except that the Student license will cease to function at the end of its term, as noted below.

If you have a Student registration, the license is granted only to a bona-fide full-time student (with appropriate proof) for a period of time limited to 3 years from the date the first approval code is issued to the serial number shown on the reverse side of this page. After that period, the software will cease to function and the license is terminated.

Your license applies only to *Lightwright* version 4 and *Beamwright* version 4 and does not give you the right to use version 5 or later of either product without paying the appropriate upgrade fee.

The name you register under must match the kind of license you purchased. If you purchased an Individual or Student registration, then the registration must be in the name of an actual living individual, not the name of an organization or a person's title or pseudonym. If you purchased an institutional registration, then the registration should be in the name of the organization that purchased it. If the name is subsequently proven to be false, misleading, or otherwise outside of the terms of this license, then this license is immediately void without recourse by you. For legal purposes, the owner of the license is considered the name submitted on this form or on the web site registration form as "Registered Name" at the time of registration approval, and cannot be substantially changed later.

Any other use is illegal.

Finally, remember that the theatre business is very, very small and pirated copies of *Lightwright* and *Beamwright* are easy to trace. If someone has your registration information and uses the software outside the terms of this license agreement, then you are considered a responsible party in any legal action taken against the person using the software under your serial number.
